#### About us

Healthwatch is a local and national health and social care champion, established in each local authority area in England in accordance with the Health and Social Care Act 2012. There are 152 Healthwatch in England, there are 10 Healthwatch in Greater Manchester, of which Stockport is one and we all are part of the Greater Manchester ICS.

Healthwatch Stockport is an established independent organisation supporting the Stockport community to get the best out of their health and social care services through engagement and involvement in the commissioning and provision of local services.

We are an independent statutory body, we obtain the views of local people about their needs and experiences of care and make those views known to leaders who commission, provide and scrutinise services in localities.

#### About the role

#### **Hours**

The hours are up to 28 per week over 4 days and there is opportunity to work these flexibly by agreement

We have an office based in Stockport and we aim to be as visible as possible to our Stockport residents. There is also the opportunity to work some hours flexibly from home.

We are looking for a skilled officer to work closely with a wide range of Healthwatch Stockport members and other stakeholders to ensure the organisation's strategy and its priorities are met. You'll be joining an established team to help reshape how we support the work of Healthwatch to be most effective.

We want to work with someone who is a team player and can work collaboratively with our stakeholders across all our projects. You will be able to effortlessly network, build trust and develop relationships with diverse stakeholders including residents, service users and carers, voluntary organisations, service providers, and colleagues in other Healthwatch organisations

The successful candidate will have excellent project management skills, be a great communicator, will be knowledgeable about the vibrant voluntary and community sector in Stockport and knowledge and experience in health and social care will be key.

We need someone who can manage competing priorities, demonstrate our impact with written reports, and present to several different key audiences.



As a Senior Officer you will be responsible for implementing new projects involving our staff team, Healthwatch members, engaging diverse local groups about their health and social care experiences. You will attend events and meetings to recruit new Healthwatch members, and involve motivate and train existing members, coordinating representation of Healthwatch Stockport where it is relevant.

You will also assist and oversee our Enter and View Training programme, supporting members to undertake visits to places of care to understand people's experiences of local services. You can find out more details about Enter and View here.



### **Application Process**

- 1. All forms of application are to be completed through the Healthwatch Stockport website.
- 2. All applications are anonymous during shortlisting to ensure fairness and consistency. If you have been shortlisted, you will receive an email informing you of this and further details regarding the next stage of the process.
- 3.All Healthwatch Stockport positions are assessed differently depending on the vacancy's criteria. The different formats consist of an interview, in-tray exercise, written exercise, group activity, presentation, etc...
- 4.Once you have successfully passed the assessment stage, you are offered the role. You are then sent a HR 'Welcome Pack' so that you're able commence your preemployment checks.



# FAQ's

## Q1. Can I claim back expenses incurred during the recruitment process?

No. Unfortunately, we will not be able to reimburse you, except in exceptional circumstances and only when agreed in advance.

## Q2. What shall I do if I have a break in employment?

If you have a break in employment, please state this within your employment history and references section with the dates you were taking the break.

## Q3. What reasonable adjustments can be made if I have a disability?

We are committed to making reasonable adjustments in order to support disabled job applicants and ensure that you are not disadvantaged in the recruitment and assessment process.

Reasonable adjustments include allowing extra time during selection tests, ensuring information is provided in an accessible format, etc.

If you feel that you need a reasonable adjustment to be made, let us know.

## Q4. Will you request my references before I hand my notice in?

No. Our HR Services Team will wait until your approval before approaching your referees.

# Q5. How long will I have to wait before finding out whether I have been successful after an interview?

We aim to get back to candidates as soon as possible after an assessment event takes place. If you are successful, we will contact you via telephone. However, if you are unsuccessful, you will receive an email.

# Q6. If I have been unsuccessful in gaining a role, can I apply again for another role straight after?

Yes. We don't have a waiting period and therefore you are more than welcome to apply for as many roles as you would like.
